

- To understand what support is available for modern slavery victims.






TYPES OF EXPLOITATION

There are several broad categories linked to Modern Slavery ALL prioritise profit over people.

- Sexual Exploitation
- Forced Labour
- Forced Criminality
- Domestic Servitude
- Organ Harvesting
- Child Exploitation

Did you know? Latest figures suggest 40 Million Worldwide and over 100,000 in the UK



SLOVE Exploitation in the Care Sector

- Care sector added to Sponsorship Visa ; Shortage Occupations
- Around 165,000 estimated vacancies across the UK
- Hundreds of Care Homes across the area (Plus similar Domiciliary Care)
- Exploitation of workers
- Multi Agency Meeting

SIGNS & INDICATORS

- Having no personal identification or passport/documents held by someone else
- Lack of money/control over own finances or excessive wage reductions
- Living/sleeping in place of work
- Evidence of control of movement either as an individual or a group
- Limited contact with family and/or limited social contact
- Others seeking to speak for the person you are trying to engage with
- Living or found in 'degrading' conditions
- Multiple occupancy living accommodation





SIGNS & INDICATORS

- Children not in education
- Children living with non-relevant families or relationship between child and adult unclear
- Signs of branding/ ownership
- Perception of being in debt to someone
- Injuries apparently as a result of assault or ill treatment, as a result of work, or from restraints such as shackles or rope
- Limited access to medical or dental care
- Fearful of police or authority figures
- Evidence of fear towards a dominant male or female (fear, shying away, overly suggestive)
- Lifestyles they cannot afford e.g. new mobile, clothes, money etc.



MODERN Slavery

BARRIERS TO DISCLOSING

- Lack of awareness that they are a victim
- Unaware that help is available
- Language barriers
- Controlled movement
- Fear of repercussions (to themselves or family)
- Always accompanied by trafficker
- Isolation
- Feel they are better off in current situation than previous one
- Immigration status
- Involvement in criminal activity
- Juju (witchcraft)
- Lack of trust in authorities
- Self-blame
- Stigma
- 'Stockholm Syndrome'

MODERN Slavery

NRM PROVIDES

The NRM contract is provided by The Salvation Army in England. It provides:

• Safe housing (minimum of 2 hours away)

•Legal Advice


- Health care (including alcohol/drug rehabilitation)
- Counselling
- Educational opportunities (including language training)
- Repatriation assistance

The NRM provision is provided by BAWSO in Wales, TARA or Migrant Helpline in Scotland and Migrant Helpline or Women's Aid in Northern Ireland.
